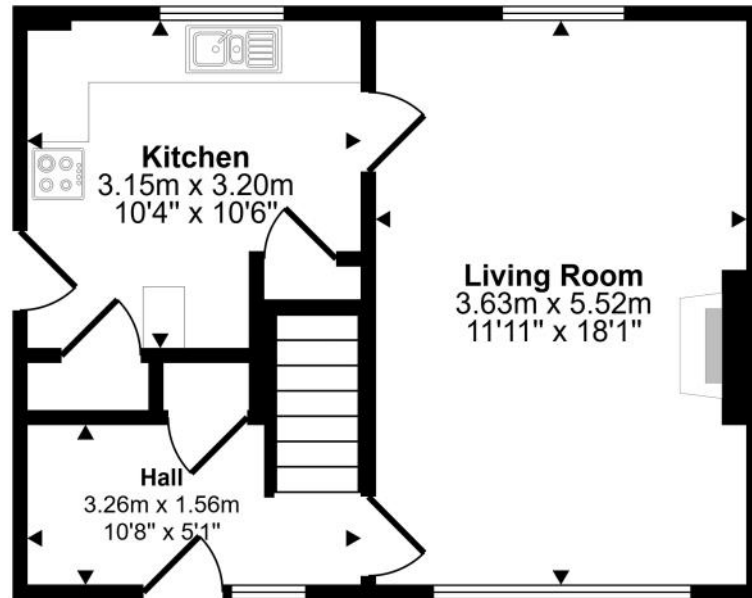

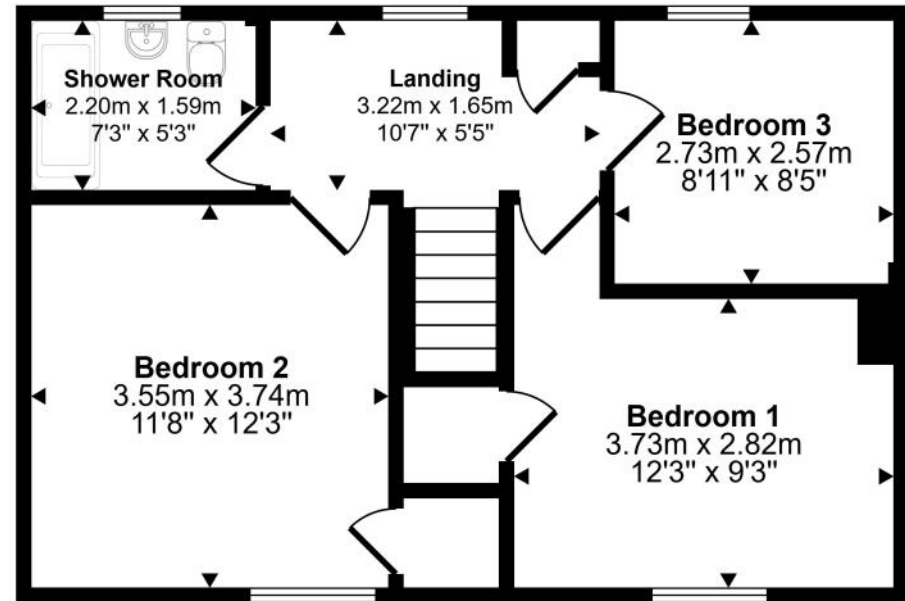

Just after the pedestrian crossing (opposite ASDA) turn left, Montgomerie Street and continue to end of street turning left to The Avenue. Proceed ahead and turn right to Queens Drive. At junction turn right North Park Avenue. Continue ahead and turn left Victory Park. Ahead to junction and left to South Park Avenue. Proceed ahead and turn right Motehill Road, continue up hill and at junction veer left and then proceed ahead turning 1st left Todd Street.
